CRFM MEMBER COUNTRIES JOIN THE GLOBAL FIGHT AGAINST FISHERIES CRIME

Officially inaugurated in March 2003, the Caribbean Regional Fisheries Mechanism (CRFM)-an inter-governmental organization with a mandate to promote the sustainable development of our marine living resources for the economic and social benefits of the Caribbean-has been leading the region's fight against fisheries crimes.

Since 2010, the CRFM, with its 17 Member States and regional and international development partners, has been taking a series of bold actions to address fisheries-related crimes.

CRFM Member States signed the Copenhagen Declaration *en bloc* in October 2021 and pledged support for the Blue Justice Initiative (BJI).
